Bazaar Rules & Regulations

General Guidelines

- ❖ Vendors may set up their table(s) on:
Friday July 12, 2019 from 3:00pm-6:00pm or Saturday July 13, 2019 at 7:00am.
- ❖ Table(s) and location will be assigned by the Committee on a first paid, first come basis.
- ❖ Vendors agree that their merchandise will strictly conform to the type approved in their application.
- ❖ The Committee reserves the right to refuse or terminate any vendor who does not comply with the guidelines.

Registration:

- ❖ To register and reserve your table(s) each vendor must complete and sign a vendor application form. Please complete and sign form and mail with payment to: St. Patrick Women's Club, P. O. Box 164, Bisbee, AZ 85603. Please make check payable to: St. Patrick Women's Club.

Set-up and Operation of Vendors Booth:

- ❖ Each vendor will be provided one 6' rectangular table and 2 chairs. One additional table is available for an additional fee. 1st table \$20.00 fee; 2nd table \$10.00 fee.
- ❖ Each vendor will be given space according to the number of table(s) rented.
- ❖ Outside vendors agree to provide their own set-up materials, tent, or canopy
- ❖ Vendors agree to be fully set-up, merchandise displayed and ready to sell to the public by 9:00am
- ❖ Early closing: Vendors agree to remain open until 4:30pm
- ❖ Upon the conclusion of the Bazaar, each vendor will be responsible for removal of merchandise, including any props, personal items or trash.

Refund/Cancellation Policy:

If a vendor cancels after June 25, 2019: the 1st table fee of \$20.00 is non-refundable; the 2nd table fee will be refunded. Absolutely no refunds will be issued due to weather or failure to show up.

Vendors acknowledge and agree that St. Patrick Women's Club/Committee, St Patrick Church or the Dioceses of Tucson, and their respective officers, directors, employees, agents and representatives shall not be liable for any loss or damage to vendor's property while located on St. Patrick Church premises.
